The European Regulation on the Registration, Evaluation, Authorization and Restriction of Chemicals (REACH) was enacted in June 2007, and is designed to consolidate various pieces of legislation within Europe and improve the level of information available on chemical usage within the supply chain. Of particular concern are the chemicals on the Substance of Very High Concern Candidate List.

NICKEL	<0,5 pg/cm <sup>2</sup> /week
LEAD	Equal or greater than 0,05 % by weight
